These full body harnesses can alternatively be equipped with a lanyard type Band B3 or a lanyard with an integrated energy absorber type Tyger 3 as well as a waist fall arrest element (EN 353-1) and in the MAS 90 and MAS 90 Quick versions, with attachment elements for rescue on both shoulders.

The full body harnesses were tested for nominal loads up to 136 kg. Under certain conditions and if the full body harness will be equipped with the lanyard type Tyger 3, it can also be used in a horizontal arrangement if a loading over an edge is to be expected in case of a fall.
